V. HEALTH HAZARD INFORMATION

Effects of Exposure:

To the best of our knowledge the chemical, physical and toxicological properties of NbN have not been thoroughly investigated and recorded.

Nitride Ceramic: Industrially, this element does not constitute an important health hazard. Exposure is related chiefly to the dust arising from the crushing and milling of the two chief ores. Large overdoses cause central nervous system disturbances, diarrhea, respiratory failure and death in experimental animals.

Inhalation: Acute: Powder may cause irritation to the lungs and respiratory tract.
